COVID-19 Protocols – Vaccination Policy
RENEWED: July 23, 2022

This policy was initially adopted on July 15, 2021, renewed on July 23, 2022, and will remain in effect (does not expire) until amended or rescinded by vote of the Board of Directors.

Musica Sacra Foundation (“Musica Sacra”) takes the health and wellbeing of our vocal and instrumental performers extremely seriously.

Therefore, in an effort to maintain as safe and healthy of an environment as possible for all who perform with Musica Sacra, the Board of Directors has again voted unanimously to require that all performers, volunteers, temporary workers and independent contractors be fully vaccinated against COVID-19 prior to participation in any of Musica Sacra’s in-person activities, including rehearsals or performances.

Due to the higher risk of the spread of respiratory illness associated with the activity of singing, and because participation in Musica Sacra is voluntary, no exemptions or accommodations to this policy will be granted, including but not limited to, proof of prior infection or a negative test. Individuals who are not in compliance with the vaccination requirement will not be permitted to rehearse or perform with us.

Written assurance of vaccination status is required prior to beginning rehearsals with us, and may be provided by any of the following methods. NOTE: No personally identifying health information is retained on file by Musica Sacra.

- Written proof of vaccination from the vaccine administrator
- CDC-issued Vaccination Card
- Signed “Statement of Affirmation of COVID-19 Vaccine Status” (See our Chorus Manager for a copy.)

For the purposes of this policy, individuals are considered “fully vaccinated” two weeks after completing the second dose of a two-dose COVID-19 vaccine (e.g., Pfizer or Moderna), or two weeks after receiving a single dose of a one-dose vaccine (e.g., Johnson & Johnson). Boosters are highly recommended, but not required at this time.

This policy is designed for use together with, and not as a substitute for, other COVID-19 prevention measures which we may implement, including: wearing of masks, social distancing, temperature checks, health screening protocols, cleaning and sanitation, or any other COVID-19 prevention policies or protocols. NOTE: Some of these measures may be imposed by our rehearsal or performance venues, which is outside of Musica Sacra’s control.

Our existing sick policy remains in effect: Stay home if you are feeling ill, or if you are experiencing symptoms of respiratory illness, or if you have reason to believe you have recently been exposed to COVID-19.

Musica Sacra reserves the right to modify this policy at any time in its sole discretion to adapt to updated public health guidance, changing local circumstances, or evolving organizational needs, consistent with its commitment to maintaining a safe and healthy performance environment.
